- Numbers 2019 compared to 2022:

## **Executive Council Emergency Powers**

Continued from 2020 – 2021. As we continue to work through what is needed to respond to the pandemic.

- 1. "Freezing" quotas again at the level they were for NCFL 2020. Leagues can increase their quotas by providing the requisite school memberships, but leagues cannot have their quotas reduced if they don't get the requisite number of schools. This recognizes the continued difficulty that some schools have providing signed membership forms, and that some leagues may not have as many teams as they usually do.
- 2. Allow our NCFL Executive Committee (Diocesan League Directors) and Board Meetings to be held virtually.
- 3. Take whatever steps are necessary to hold an NCFL 2023 Tournament, either fully in-person, or hybrid or online if in-person is not possible.
- 4. Wild card entries used by leagues in response to COVID Registration changes will not be subject to the 5 year wait period.

Motion made & seconded to continue previously granted Emergency Powers (see prior minutes) - PASSED without objection



# Changes Made We'd Like To Keep

- 1. An Informational Diocesan Directors meeting may be held virtually on the Saturday before NCFL 2023, May 20.
- 2. OnLine Judge Training and a Ballot Test may be held during the week preceding NCFL 2023.
- 3. Equity & Bias Training for Judges may be made available during the week preceding NCFL 2023.
- 4. A Two-Tiered OnLine "Start of Tournament" Registration approach, first for Leagues and then for Schools, may be held on Thursday and Friday of NCFL 2023, May 25-26.
- 5. An OnLine Help Desk may be maintained for NCFL 2023, similar to what was used for NCFL 2021.
- 6. Use of FlipGrid to allow students to record their names to help with pronunciation during Awards
- 7. We may continue to skip the opening meetings like we did in DC 2022



# We ARE Planning for In-Person NCFL 2023

#### May 27 - 28, 2023

- Louisville, KY
- 1. Tournament Entry and Judge Quotas would be those specified in the ByLaws.
- 2. LD & PF would be double-flighted, with a Play-In Round as specified in the ByLaws.
- 3. We will be subject to any Health & Safety Mandates of Louisville, KY, the University of Louisville, our Host Schools, and our Host Hotels. These may include the requirements for vaccination and/or testing, and that all attendees wear masks at all times when indoors (not in individual hotel sleeping rooms). We will keep you posted as we get closer and know what mandates will apply.

## Item VII.A., By-Laws

## NCFL By-Laws, Article II, Section C, 4, f.

The Wording Committee will prepare between four three and six four topics each for LD and PF Debate based on the given topic areas. At least three two of the topic areas each for LD and PF Debate should be reflected in the prepared topics.

Ashley (Philadelphia) - provided rationale and thought process behind the proposal

Discussion -

Dave - will the potential for only two topic areas provide a "lesser of two evils" choice?

Motion to Amend (& seconded) to strike "At least" and leave original "three"

Not accepted as "friendly"

Vote: 9 yes/11 no - Amendment fails

Greg (Boston) - Motion to call the question - seconded - question called

PASSES (weighted vote but on a clear voice approval w/o objection)



## Item VII.B., By-Laws

## NCFL By-Laws, Article II, Section C, 4, f.

Not later than April 4 March 28, the Tournament Director will provide a ballot listing the recommended PF Debate topics prepared by the Wording Committee to the Diocesan Directors. Diocesan Directors will return their vote, each voting not more than once, for the PF Debate Topics not later than April 11-April 4. Each voter will rank the topics First through Last. When voting closes, the ranks will be totaled and the topic receiving the lowest total among all the ballots cast, will be the topic for the NCFL Grand National PF Debate Tournament. In case of a tie, the topic receiving the highest number of first place votes would be chosen. The Tournament Director will publish the topic not later than April 15-April 8.

Ashley (Philadelphia) - provided rationale and thought process behind the proposal No Discussion

Motion made & seconded - Question called

PASSES (weighted vote but on a clear voice approval w/o objection)



## Item VII.C., By-Laws

#### NCFL Congress Manual, Page 5.

When many members wish to speak, the Presiding Officer will choose those who have spoken least. Presiding Officers should maintain careful records of the number of times each student has spoken and use this as a guide in the selection of speakers. The record should be shared with each following Presiding Officer as recency is not reset from round to round during preliminary sessions. At the start of each preliminary session, all students start with zero speeches (recency is reset).

Greg (Boston) provided reasoning/justification for the proposal - included that creating additional Congress chambers was not a viable option to propose - better chance at a more equitable number of speeches per student. Discussion:

Charlie - allows students to "plan their day" - helps balance the playing field

Leanne (Clerk of Congress) - neither she nor co-Clerk Keith P are in favor of this proposal as it allows students to "play the system" vs planning their day. Want to keep a level playing field for those newer to the competition.

David - point out the difference between recency and precedence

Kieran - should record keeping be done by the Parli vs PO

Richard - the students who prepare the most, stand the most and are called on more over the unprepared.

Steven - how much of a problem is it? Examples?

Greg -some students speak only 3 times and others can reach 5 or 6. His understanding that both recency & precedence reset under current rules. The proposal would actually help students not part of the national circuit group.

Richard - PO has no choice on who they pick as they must use the list. Solution in search of a problem?

David - Amendment - add "precedence and" before "recency" and change "is" to "are". Second by Kieran.

Debate on the Amendment - discussion on whether "precedence" & "recency" are defined in the Congress manual. Upon review, the definition of recency in manual includes both. Amendment withdrawn

Question called - Weighted vote (27 dioceses) - 83 Yes - 43 No - 6 abstain - PASSES



## Discussion Items

#### TBD

- Zoom option those on this weekend appreciated it and it worked well. Will consider as an option going forward. Comment on ONLY on Zoom for equity. Comment that having ALL options is the best model.
   Hotel contractual guarantees can be an issue so hybrid meeting will require adjustments to avoid attrition fees.
- Fall meeting host locations. Chicago Sept '23? (maybe uncertain right now)
- Site visits at Fall meetings why not happening/will they? Feedback given was that they were not overly helpful but not opposed in any given year if it seems to be needed/possible. Recommendation for hosts to attempt to do a video (GoPro) "tour" of sites to put on the tournament website for all beforehand. Often times sites for exact categories still in flux in the Fall. Advocacy for a tour regardless to see logistical aspects (parking, etc...) to pass along.
- Virtual Directors Meeting a week before the tournament important that all leagues have a representative.
